MINUTES-June 6, 2019 Special Session

The Council of the Municipality of Brooke-Alvinston met in Special Session on Thursday, June 6, 2019 at 4:30 p.m. to hold a Special Meeting of Council. The matter on the agenda was closed meeting business followed by discussion on the proposed pole shed.

1. MOVE OUT OF IN CAMERA

<u>RISE AND REPORT</u> The Clerk Administrator was asked to rise and report. She reported that a closed meeting was held to discuss a matter regarding personal matters about an identifiable individual including municipal employees and in accordance with s.239(2) of the Municipal Act.

## 4. <u>DISCLOSURE OF PECUNIARY INTEREST</u>

Mayor Ferguson requested that any pecuniary interest(s) be declared when applicable.

## 5. <u>DELEGATION</u>

The Mayor allowed Theresa Goodhand to speak at the meeting. Mrs. Goodhand commented on the town buildings including the community centre and their upkeep. She stated that there was a lot of stuff that should be thrown out or sold to make room. She stated that the Lorne Street shop could have the heat and water shut off and used as a storage shed and if sold, it should be sold by public auction and disclosed that there is contamination from the fuel tanks. She cautioned against placing fuel tanks at the fairgrounds due to the Canada Day fireworks; She commented that there have been private meetings of staff and committees. It was further noted by Mrs. Goodhand that Council should step up whilst the Clerk Administrator and Public Works Manager step down. She stated that there is a possible conflict of interest between the contractor of the proposed pole shed and staff / Council.

Councillor Nemcek commented that he is hopeful the sale of the town shop would assist with the funds of the proposed pole shed.

Councillor Armstrong suggested a 1600 ft2 lean-to be built to the existing Barn A for exclusive use of the Municipality

Councillor Deans questioned if a lease agreement between the Fair Board and the Municipality was discussed; and noted the proposed pole shed funds should go towards the Optimist Pavilion Project. Further comments were received from the public.

#### 6. <u>BUSINESS</u>

## i) Proposed Pole Shed

The Mayor requested the Clerk Administrator to present her submitted report to Council. The report included:

-Background information on the budget meetings

-use of the pole shed with a contents list also supplied

-the petition from Theresa Goodhand with number of signatures (approx.. 235)

-Consultation comments on the pole shed comments from the Advisory Committee and Board of Directors for the Fair Board

The submitted letters regarding the pole shed from Marilyn & Doug Dolbear, Nettie Ellison and Theresa & Jim Goodhand. The letter from the Alvinston & Optimist Club was also mentioned.

Comments from the public were received in regards to the negative image the Municipality receives and the Pavilion Project. It was reiterated by the Mayor that the Pavilion Project is an Optimist Project. After further discussion the Mayor requested a motion from Council to move the proposed pole shed ahead or not.

Moved by Councillor Nemcek / Seconded by Councillor Douglas Be it resolved that the Council of the Municipality of Brooke-Alvinston move forward with the proposed pole shed as presented in the 2019 municipal budget and its location be on the west side of the Fair Board's Barn A; and that the Public Works Manager present to the Fair Board a detailed layout prior to construction to show access routes.
