Dear Clerk and Valuer:

On July 1, 2011, the new Ontario Wildlife Damage Compensation Program came into effect. The updated program was developed by the ministry in consultation with producers and municipalities. The ministry recognizes and values the excellent work you do to make this program a success.

This program offers compensation to producers for livestock and poultry killed or injured by wildlife. The updated program also provides our municipal delivery partners with \$30 per claim to assist the administration costs, a feature that was not a part of the previous program.

To be eligible for compensation, livestock and poultry producers must have a Premises ID number and a valid Farm Business Registration number, or one of the allowable exemptions. Since the program came into effect, there has been a high frequency of application forms missing these numbers.

For livestock and poultry killed or injured on or after April 1, 2012, the producer must provide a Premises ID number and a valid Farm Business Registration number on the Program Application (i.e. valuer's report) for a claim to be eligible for the Ontario Wildlife Damage Compensation Program, Municipal valuers must collect these numbers at the time of the inspection or shortly thereafter in order to submit the Program Application within the 10-day service standards outlined in the program guidelines.

NOTE: The ministry will not reimburse municipalities for claims missing these numbers for livestock and poultry killed or injured on April 1, 2012 or later.

I encourage municipal valuers to inform livestock and poultry owners of these requirements during their inspections. To help communicate that information, I have enclosed an information sheet that explains how livestock and poultry producers can apply for a Premises ID number and a Farm Business Registration number.

## Ontario Wildlife Damage Compensation Program

## Program Eligibility Requirements for Livestock and Poultry Killed or Injured by Wildlife

When the Ontario Wildlife Damage Compensation Program was launched in July 2011, two new eligibility requirements for livestock and poultry producers were created in order to be eligible for compensation. These eligibility requirements include having a Premises ID number and a valid Farm Business Registration number.

If you don't have a valid Farm Business Registration and Premises ID number, please apply now for these numbers in order to be eligible for compensation under the updated program.

#### Applying for a Farm Business Registration (FBR) Number

Having a Farm Business Registration number helps ensure that the Ontario Wildlife Damage Compensation Program is targeted for farmers.

If you already have an FBR number, renewal packages are typically mailed to you in January. If you are a new registrant, please contact Agricorp at 1-866-327-3678 or at fbr@agricorp.com.

If you are unable to obtain/renew your FBR number because your gross farm income was less than \$7,000, you may be able to obtain a "Gross Farm Income Exemption Certificate" and remain eligible for the Ontario Wildlife Damage Compensation Program if you are able to demonstrate that one of the following income exemptions applies:

- Not a Normal Production Year Exemption
- Age/Illness/Death Exemption
- Start-Up Exemption

Please note, producers with a Religious Exemption approved by the Agriculture, Food and Rural Affairs Appeal Tribunal, or a confirmation letter from the Indian Agricultural Program of Ontario, will not be required to have an FBR number in order to be eligible for the Ontario Wildlife Damage Compensation Program.

#### Applying for a Premises ID (PID) Number

Registering your premises helps Ontario establish a comprehensive and effective premises registry, a critical element of our provincial emergency management capacity. There is no cost associated with registering your premises.

To apply, you will need the following information to properly identify one or more parcels of land:

- The most accurate way to identify your land parcel(s) is to provide Assessment Roll Numbers (ARNs) which is the tax
  assessment roll number provided by the Municipal Property Assessment Corporation (MPAC) for every parcel of land.
- Alternative means to identify your land parcel(s) include providing:
  - GPS (Global Positioning Satellite) coordinates (longitude and latitude)
  - Municipal address(es)
  - Lot, concession, township and county information

Premises ID numbers cannot be assigned unless the land parcel(s) can be validated against official Ontario land registry information. You do not need to own a parcel of land to apply for a Premises ID number. Multiple numbers are not assigned to the same parcel of land even if more than one applicant applies.

When your premises information has been validated you will be assigned one or more unique Premises ID number(s).

Exemptions to the Premises ID number requirement for the Ontario Wildlife Damage Compensation Program exist for producers with a confirmation letter provided by the Indian Agricultural Program of Ontario or if a Premises ID number is not available in a particular area, such as agricultural activity on crown land.
